BACKGROUND INFORMATION ON VANUATU CLIMATE

- Vanuatu an archipelago of 80 island, population of 250,000 people.
- Vanuatu's largely patrilineal traditional governance system.
- The most disaster prone in the pacific region.
- Ranked at the high end of vulnerability spectrum.
- 1960 to 2011. increase in Vanuatu's Temperatures, erratic rainfall patterns and rising sea levels.
- 1969 to 2010, 94 cyclone have passed through Vanuatu.
- Increase of women's role during disaster or emergency.
- Vulnerability increase of women and children group.
- 2011, 300% increase of new DV case after two cyclone in Tanna Island.
- Vanuatu biggest sector affected by CC is Agriculture. 75% population live in rural.

THE ENABLING ENVIRONMENT

- Vanuatu has ratified CEDAW in 1995.
- I].2012, Establishment of NAB –PMU:
- Supreme policy making body for all climate all CC and DRR initiatives.
- NAB-PMU, consisted of 20 member and 4 of them are women.
- PMU also played the secretarial role to the NAB.
- Development of the project concept form that include an additional column on Gender impact.
- 2013, Through NAB-PMU, Gender submission was made to the UNFCCC on women increase in UNFCCC processes.
- 2013, 50% of women in the Vanuatu delegation to COP19.

GENDER MAINSTREAMING WITHIN GOVERNMENT POLICIES.

- Current draft CC/DRR policy recognise women are most vulnerable to CC.
- Specific themes on needs/ capabilities/ challenges of women were included in the National Sustainable Development Plan of Vanuatu.
- Strategy for CC/DRR Development in the Pacific (roadmap for CC/DRR post 2015) acknowledged the vulnerabilities of women.

KEY ISSUES AND CHALLENGES

- Less women participation in DRM organisations.
- Limited participation of women at the community level
- At the National level VHT and NAB are challenged to ensure gender mainstreaming in CC and DRM policies.
- DWA has the limited capacity to ensure Gender is mainstreamed at all level of the government.

BEST PRACTISES

- In August 2014, 2 Woman Vanuatu travelled trough cities of Australia advocating on action the Vanuatu communities are taking to deal with CC.
- Futuna: Provision of Agriculture and Gender Training to both male and female and result into Empowerment of Women.
- 50/50 male /female are represented in CRCCCs
- COP 19: 50% of women are part of the delegation, consulted trough the process of National Position and intervention made during COP.
