# Project Objective



#### Purpose/objective

The Vanuatu Community-based Climate Resilience Project (VCCRP) aims to ensure:

- that communities across Vanuatu have reduced vulnerability and increased resilience in the face of climate variability and extremes, and
- the adaptive capacity needed to maintain sustainable development pathways across a range of potential climate futures.

#### The Journey so far....


- A series of program development activities took place from 2016 – 2018 involving in depth consultations with former NDA, line ministries and civil society
- April 2017 concept note presented to NAB and endorsed by former NDA
- November 2019 Save the Children accreditation
- February 2020 concept note approved as a proposal by the NAB
- August 2020 Updated concept note submitted to GCF, pre- clearance given to proceed to full proposal
- October 2020- March 2021- Program design and feasibility study submitted to GCF
- 7 April 2021 NAB approval of proposal
- 19 May 2022: FUNDING APPROVAL (GCF & SCA as accredited entity signed contract)


